**WHAT YOU NEED TO KNOW:**

Intrepid Ascent, in partnership with Kaiser Permanente, Community Health Group, Blue Shield Promise, Molina, Aetna, and Health Net, is hosting an event series called CalAIM Academy! The intent of this series is to help San Diego providers avoid duplicative training by Managed Care Plans (MCPs) by bringing all local MCPs together into one training session, thereby saving providers countless training hours.
